- **Payment Information:** Processed securely through third-party providers (Paystack)
- **Class Attendance and Feedback**
- **Device and Browser Info:** Automatically collected for improving the website experience (e.g., via cookies)

We do **not knowingly collect personal information from children without the consent of a parent or guardian.**

3. How We Use Your Information

We use your information to:

- Process registrations and payments
- Contact you with class details and updates
- Deliver personalized learning content
- Monitor attendance and student progress
- Improve our curriculum, website, and services

 - With trusted partners (e.g., Zoom, Google Meet) strictly to deliver classes
 - When legally required to comply with local or international laws
